AGE TO CONSUME	21
AGE TO SERVE	19
AGE TO POUR	19
AGE TO SELL (PACKAGED LIQUOR)	19
MINORS ALLOWED ON PREMISE?	There isn't any state laws regarding minors in establishments that serve alcohol, but there can be local ordinances or polices set by the establishments.
CAN PARENTS SERVE?	It is unlawful to serve or sell alcohol to anyone under age of 21.
HOURS OF SERVICE	<b>On Premise Establishment and Off Premise/Retail Stores:</b> Monday thru Saturday: 6:00 a.m. until 1:00 a.m. Sunday sales regulated by local ordinance. State statutes do not prohibit the sale of alcoholic beverages on Election Day. However, local ordinances may prohibit sales during election hours on any Election Day.
ACCEPTED ID'S	Driver's license (any state), Nebraska I.D. card (no other state I.D cards are excepted,) Military ID card, Passport (Visa), Alien Registration Card.
LEGAL LEVEL OF INTOXICATION WHILE DRIVING	.08 BAC
DRAM SHOP LAW	NO
ID CONFISCATION	Nebraska does not prohibit licensees from confiscating false IDs. Licensees may also use a documentary proof of age.
HAPPY HOUR & OTHER SERVICE RESTRICTIONS	Licensees may not offer single-priced, unlimited service drink, specials or two-for-one drink specials. The law allows a licensee to offer a food and drink The state differentiates between "Happy Hour, " " drink specials" and/or "promotions"
PENALTIES FOR SERVING OR SELLING TO A MINOR	Class 1 misdemeanor punishable by up to 1 year imprisonment and/or up to \$1000
WARNING SIGNS REQUIRED ON EFFECTS OF ALCOHOL ON FETUS?	Any retail licensee shall post in a conspicuous place a sign which clearly reads as follows: Warning: Drinking alcoholic beverages during pregnancy can cause birth defects. The commission shall prescribe the form of such warning sign and shall make such warning available to all relationship.
